

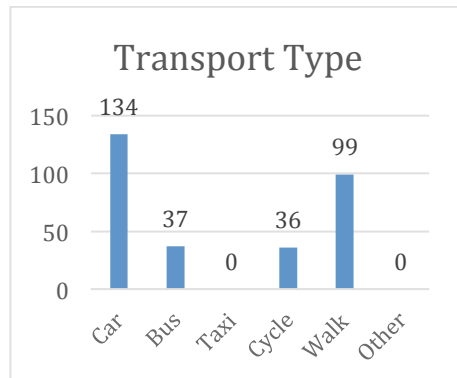

1 - INFRASTRUCTURE

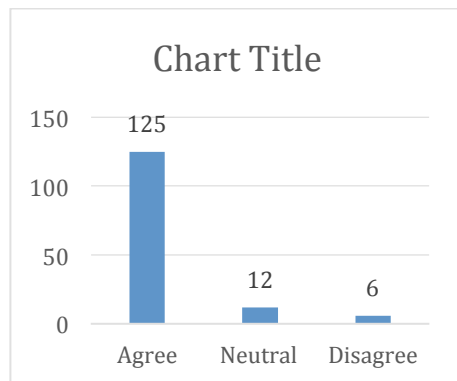
1. Transport

Please indicate the modes of transport you use most:

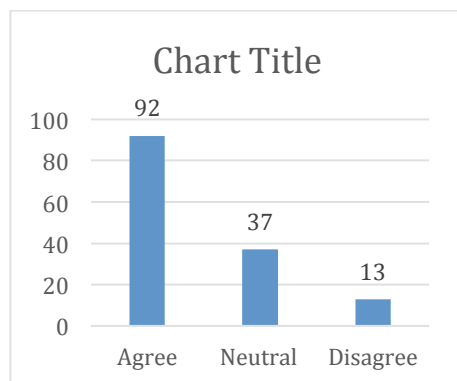


2. Roads

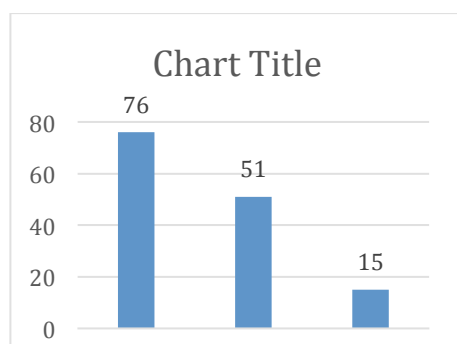
Speeding traffic is a safety issue in the village.



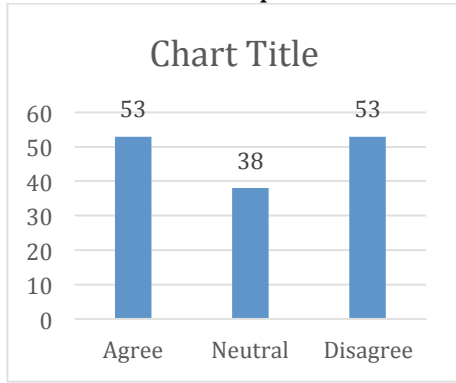
Speeding traffic is a safety issue outside the village.



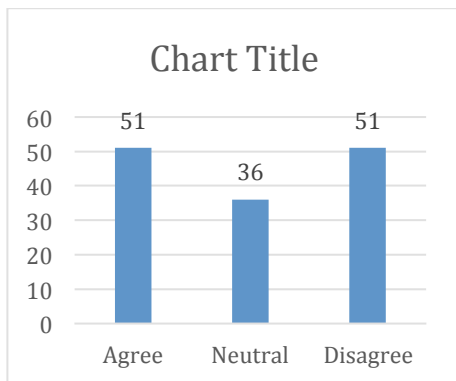
Illegal and inconsiderate street parking is a safety issue in the village.



There is sufficient provision for off street parking in the village.

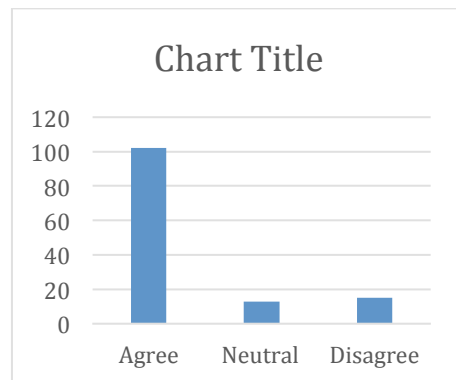


There is adequate provision for short and longer term parking in and close to the village centre.

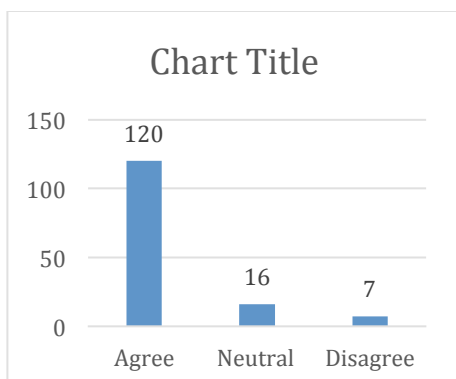


3. Paths

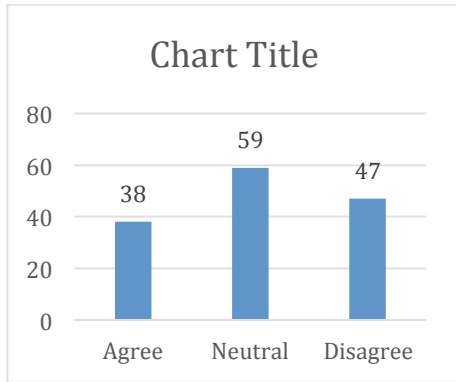
Key facilities and areas within the village are safely accessible by surfaced footpaths.



An additional network of foot and cycle paths in and around the village would promote healthy living, exercise and tourist visits.

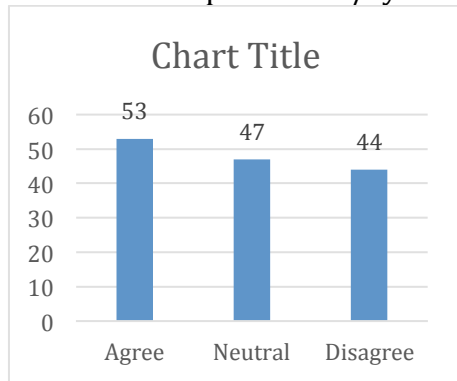


The current pavement and path network is suitable for use by people with mobility issues and people with young families.



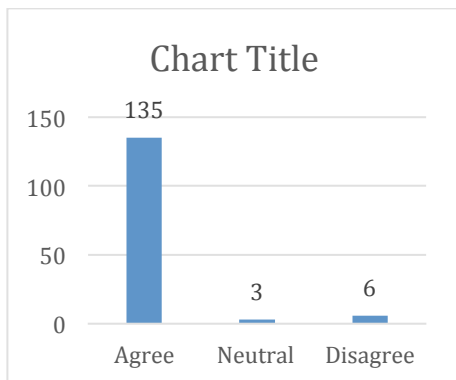
4. **Safe Routes to School**

There are safe pedestrian/cycle routes to school for children within the village.



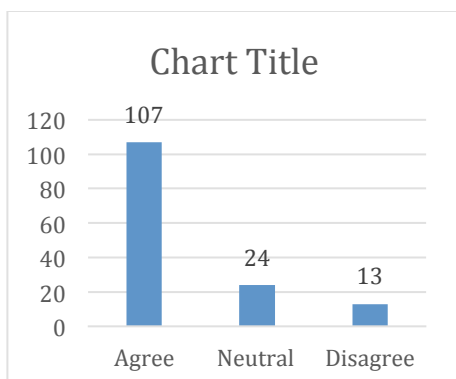
5. **Safety**

I feel safe living in the Torphins area.

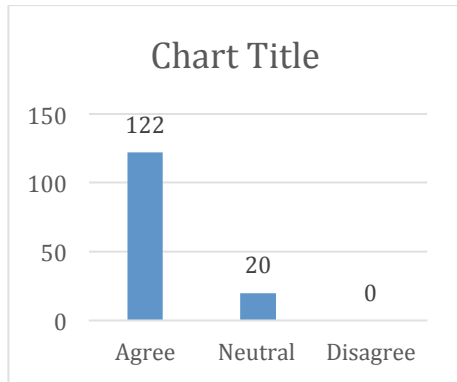


6 - **Lighting**

All areas of the village are adequately lit.

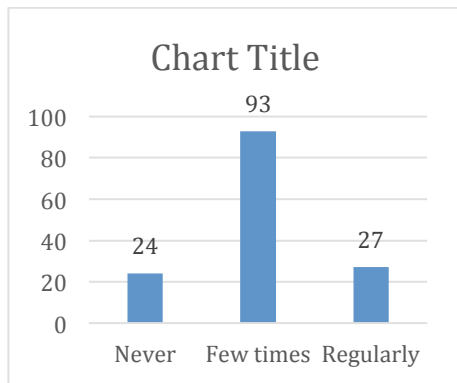


Any future street lighting in the village should minimise light pollution.

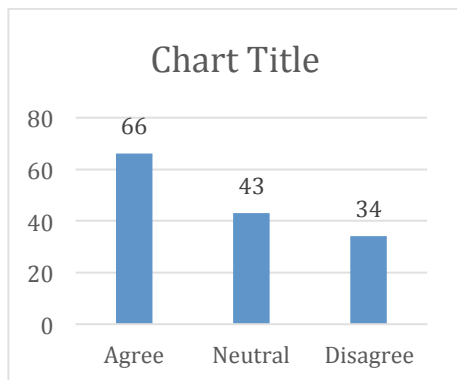


7 - Learney Hall

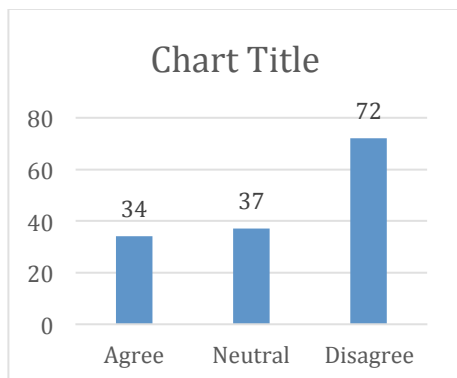
In the last year I/family members have attended events in the Learney Hall



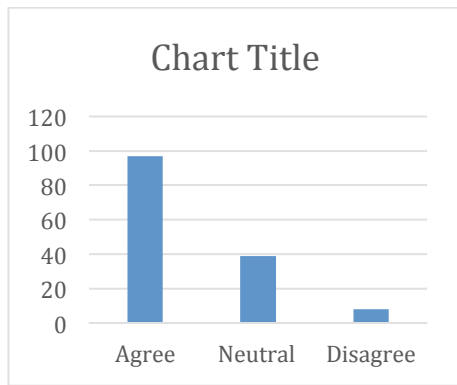
The facilities available in the Learney Hall adequately support events held.



I expect to book the Learney Hall for an event in the future.

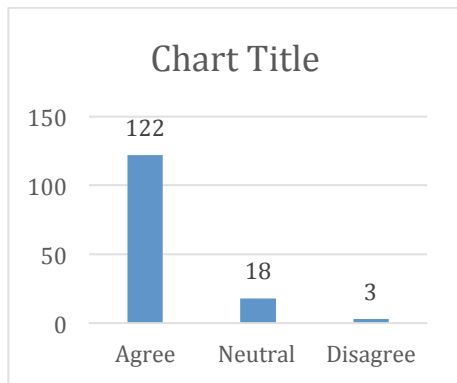


Usage of the Learney Hall would increase if the Hall is refurbished and facilities modernised.



8 - Public Toilet

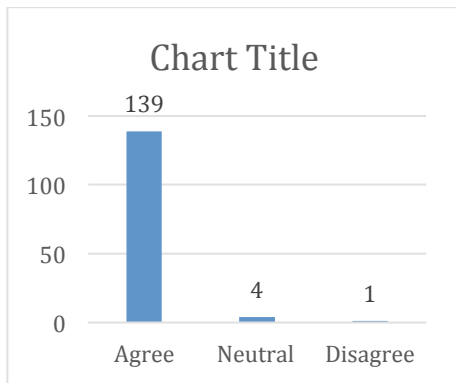
The Public Toilet in the village is an important amenity for both local people and visitors and should continue to be maintained.



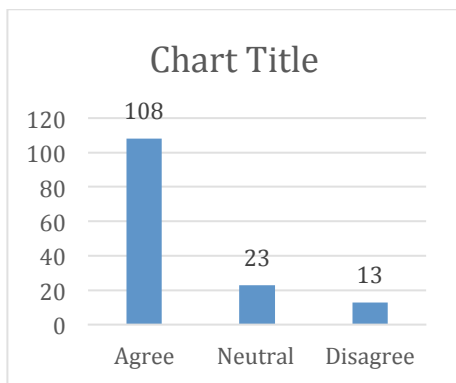

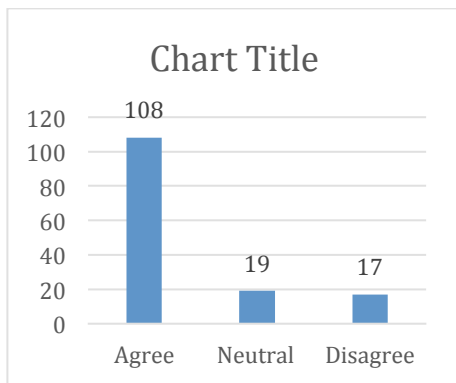
I am able to access appropriate local medical services and support for my needs?



I am able to conveniently travel to hospital facilities in Aboyne.

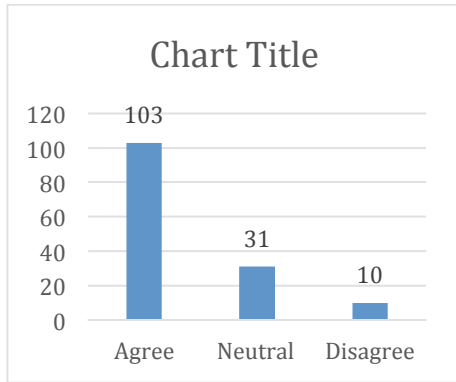


I am able to conveniently travel to hospital facilities in Aberdeen.

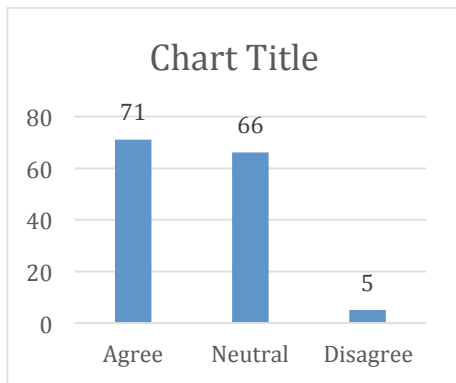


2 - Community Park

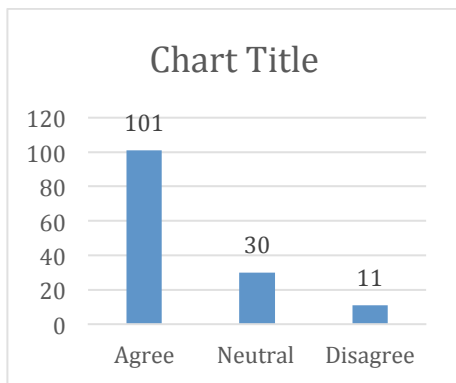
The condition of the play park and facilities provided are fit for purpose.



The changing pavilion in the park should be upgraded by the community

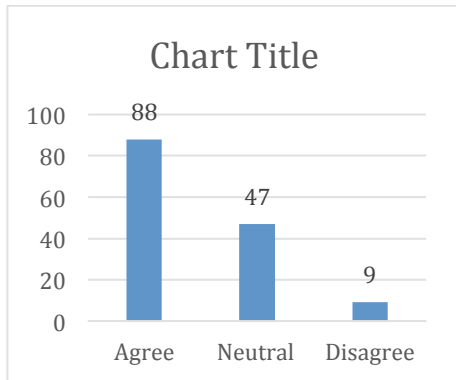


A public toilet should be provided in the play park.

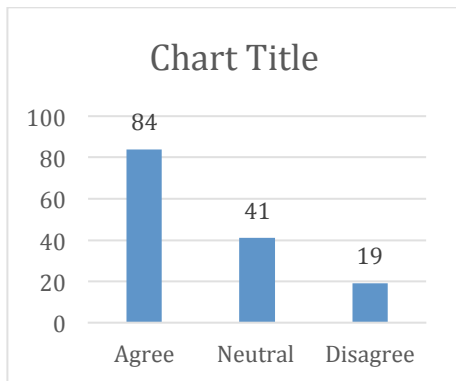

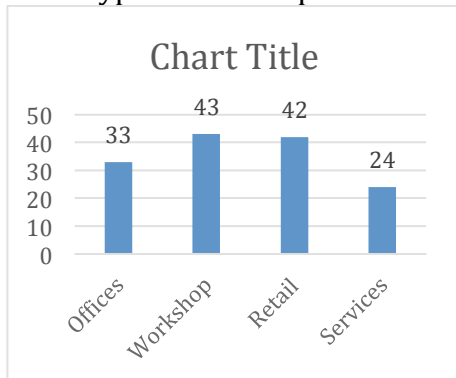
1. Torphins needs more employment opportunities within the village and surrounding area.



2. Torphins would benefit from the provision of a number of small business units.



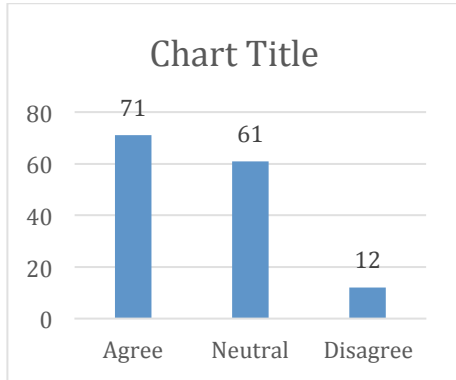

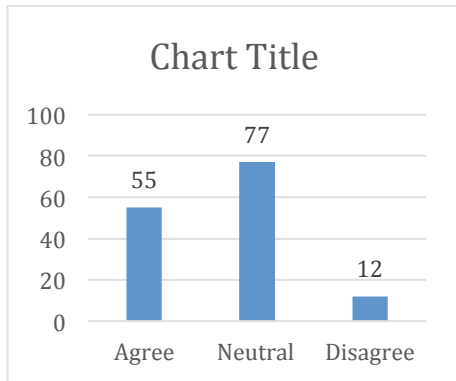
4 - EDUCATION

Torphins Primary School and Nursery adequately meets the needs of the local children.

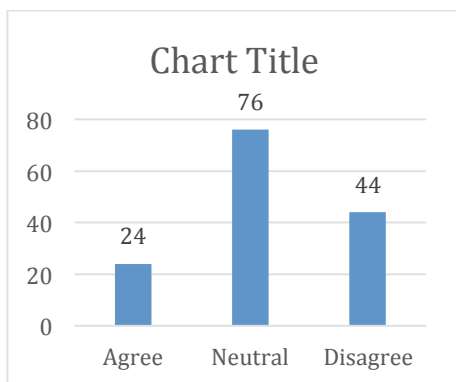


Aboyne Academy adequately meets the needs of the local children.



2. Travel to Village School

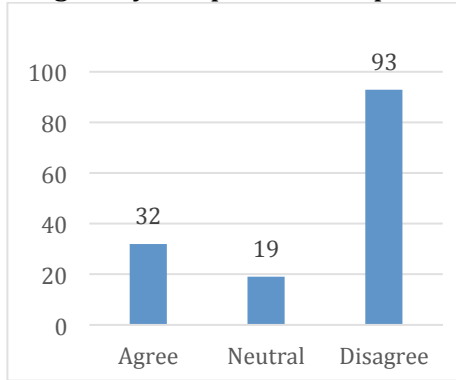
My children would walk/cycle to school if a safe route, isolated from road traffic, was provided.



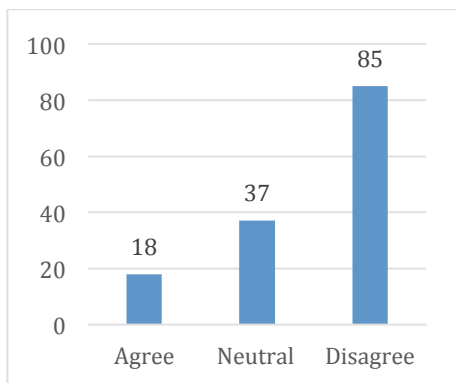
5 - SERVICES

I regularly use public transport.

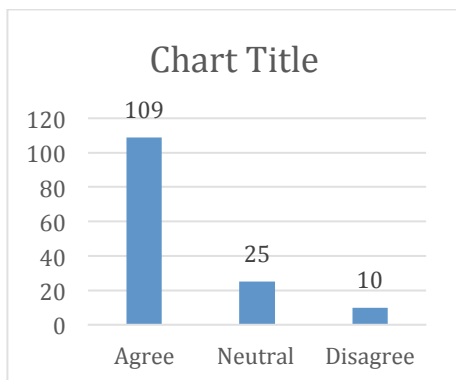


Currently provided bus services adequately serve the needs of the community for work and leisure.



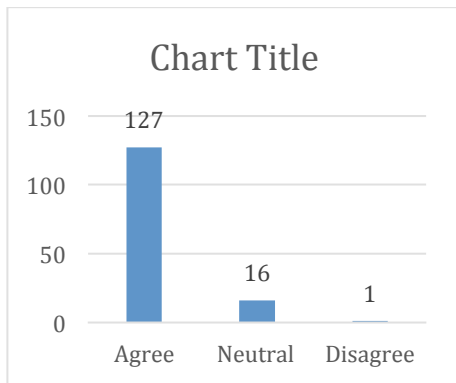
2. Utilities

High speed broadband (min 30mbs) should be available to all present and new properties in the area.

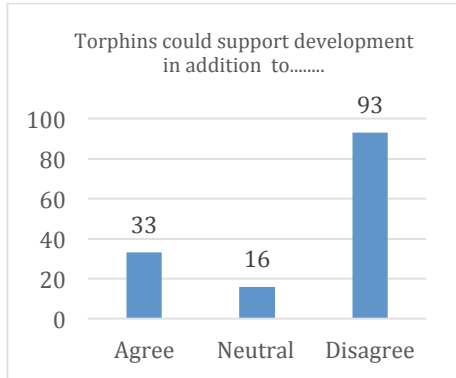

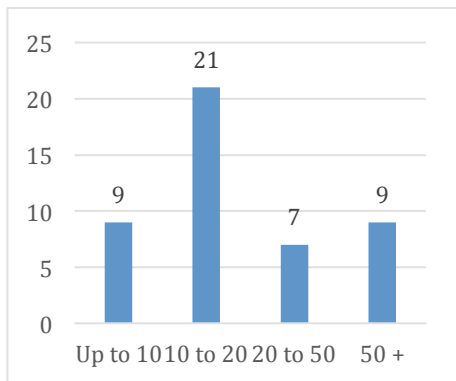
Existing Development Sites for Torphins include approximately 58 homes of various styles:

In addition to the above, Torphins could support further development.

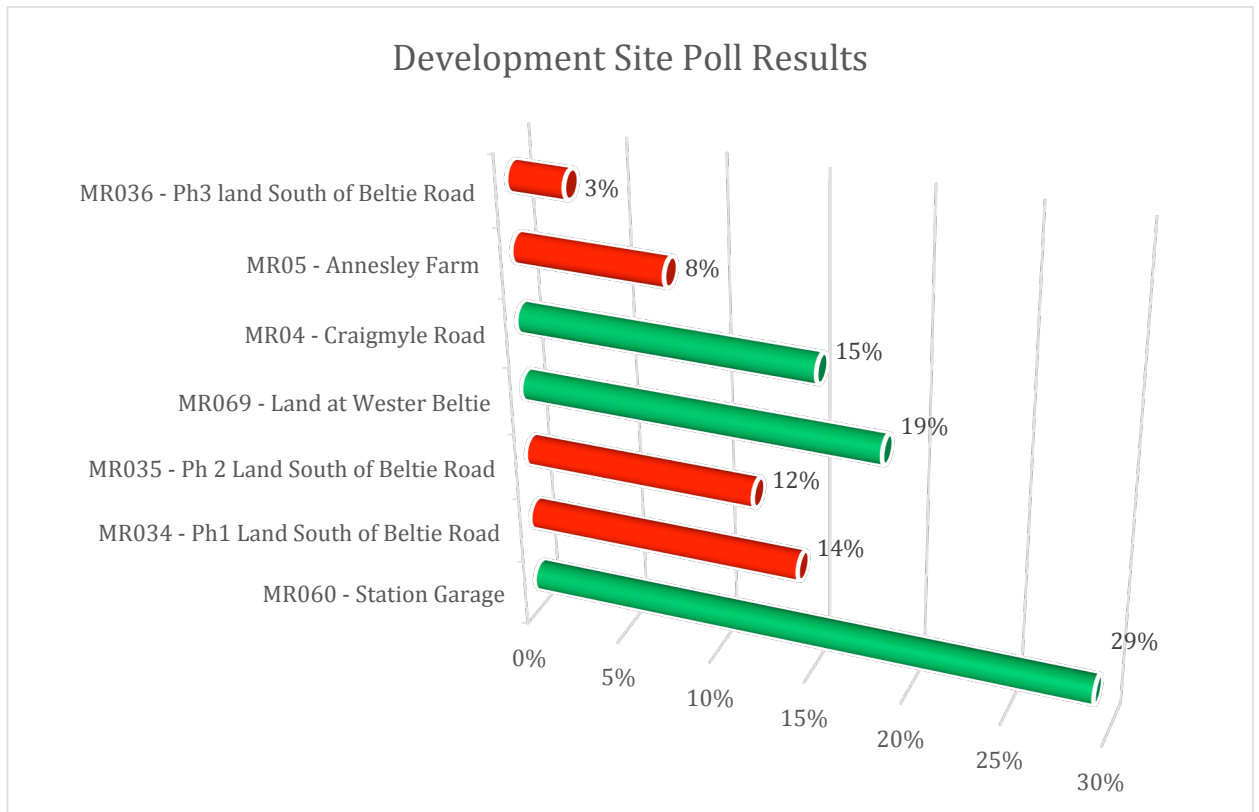
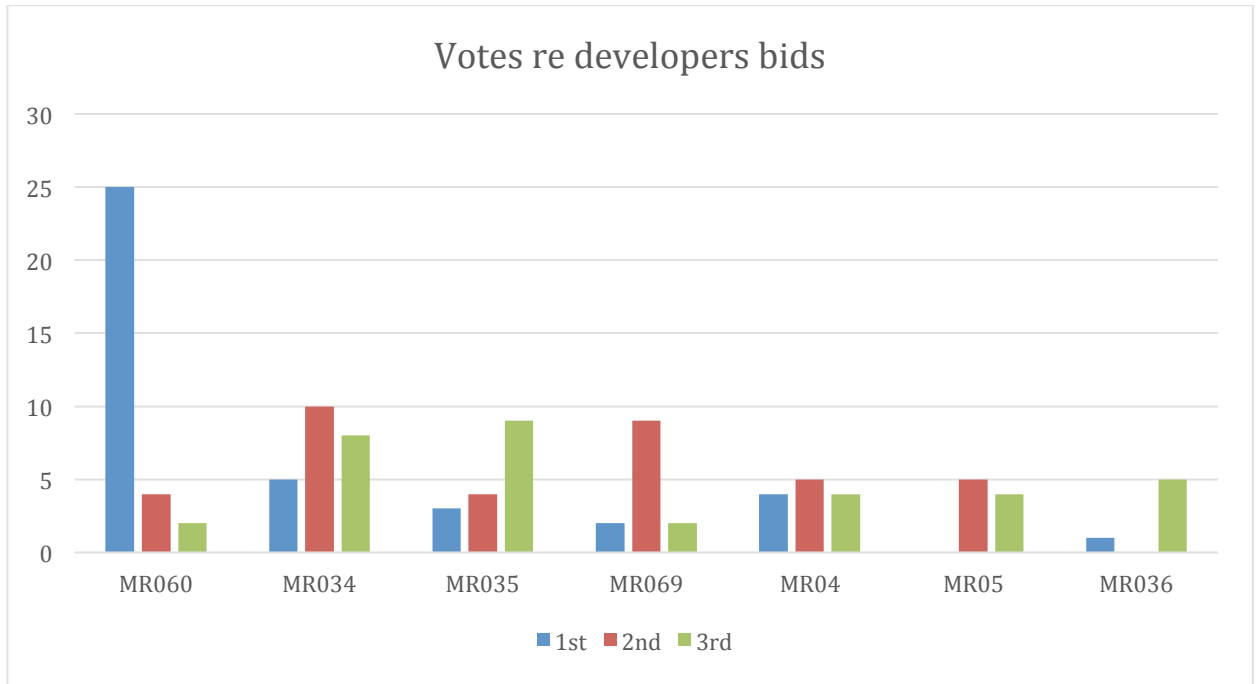

What type of houses would you like to see provided:



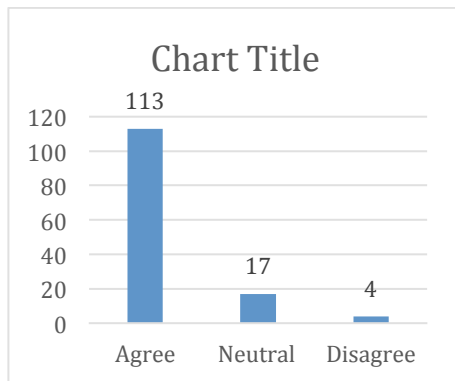
Based on the Survey Results the order of preference for Future Development is as follows:

2nd – MR069 – Wester Beltie

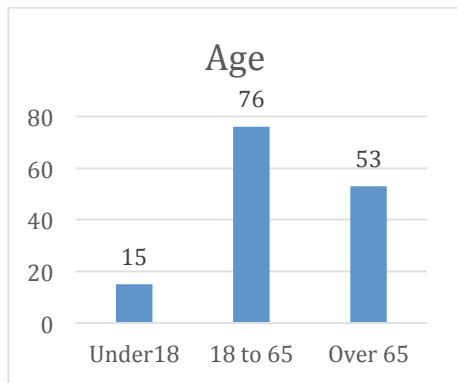
3rd – MR04 - Craigmyle Road
