Chairman's Report

In a somewhat tumultuous return to normality after COVID 19 restrictions lifted at the start of the year, Torphins and the Community Council were impacted by Storms Arwen and Malik, power outages lasting more than a week, the medical practice changing hands and local elections.

Through these events the TCC continued to successfully undertake several projects, which is something every member can feel proud of. I am grateful for everyone's continued efforts, especially when it can feel like there is an expectation of commitment rather than volunteering our time, which I know we all give as much as we can.

- There are currently eleven members with Hamish Booth retiring. The TCC are very grateful for his time and effort and diligence especially with the safety groups in the area. Warm welcome to our new member Andrew Brazier.
- Following the local elections, Councillor Geva Blackett remained while Councillors Peter Argyle and Paul Gibb were replaced by Cllr Sarah Brown and Cllr Anouk Kloppert. Cllr Argyle will be sorely missed given his many years of service as a local resident playing a key role in resolving many issues in our community and across Aberdeenshire. Cllr Gibb also made an impact locally with his useful emails during lockdown and commitment to talking larger issues like changes to the local health service (but don't mention the hall curtains!). Both regularly attended the Community Council meetings and have given the incoming Councillors a high bar to live up to!
- Potholes, speeding, and general maintenance issues have continued to be mainstay items on the agenda given budget constraints of Aberdeenshire Council. The TCC does its best to draw attention to these issues and seek quick but thorough solutions
- The Village Welcome Pack was distributed to local shops throughout the year but now requires an update
- £1280 from the Hardship fund was distributed this period and the remainder has been provided to the Resilience Team
- Having successfully lobbied Aberdeenshire Council to extend the 40mph speed limit at Campfield Petrol Station the TCC continues to push for the extension of the 30mph north along St Marnan Road.
- The Allotments group folded during this period due to a lack of participation and a difficulty in earmarking potential sites.
- The festive lighting continues to be a big success although the traditional Carols around the Christmas Tree had to be cancelled due to COVID. Eric continues to take the lead in organising and everyone donates several

weekends to erect and take the decorations down, an activity which would not be possible without the volunteers.

- In November, Storm Arwen lead to the loss of power across Torphins for over 7 days for some people, with most being out for at least two or three days. Very little assistance was offered initially by Aberdeenshire Council or the Utilities Companies, in part due to the devastation and road blockages. Everyone was affected but fortunately several local people and businesses were able to help check on neighbours, distribute food and water as well as organising warm blankets and refuges. This experience highlighted the importance of having key people on the ground, and ideally a large group of volunteers to support. To this end, TORCH – Torphins Community Help was formed to help organise aid during the next emergency.
- Unfortunately TORCH did not have long to wait with Storm Malik/Corrie arriving at the end of January. Again, many homes were without power and water for several days and TORCH did an excellent job providing assistance. TORCH are now a fully formed group and preparing plans and resources to better equip Torphins for the next emergency!
- The owners of Torphins Medical practice announced they were handing back their contract and the practice was to be retendered. This was very alarming to local residents who value the medical practice as one of the best assets in the village. The TCC arranged meetings with residents and the Health Partnership to find out what we could about this process, but this proved difficult as it was being delt with behind closed doors. Fortunately a bid was received and the new Doctor attended a TCC meeting and we look forward to seeing them around! Thanks are due to Will Maclean for his help organising and leading the TCC through these discussions.
- Finally, special thanks are due to the TCC's Secretary Will Maclean and the Treasurer Eric Day who did most of the organising and saw to the proper running of things. I am very grateful for the considerable amount of time this takes up.

The Minutes of TCC's monthly meetings are published on our website allowing members of the community to keep up to date with TCC's activities.
